



PROMO REWARDS

1. General Conditions

1.1 These terms and conditions (the "Terms and Conditions") govern the participation of users in the Promo Rewards (the "Promotion") organized by iCash.One (the "Promoter"). All capitalized terms that are not defined in these Terms and Conditions shall have the meaning ascribed to them in the General Terms <https://www.app-terms-conditions.icash.one/>. This Promotion is governed by these Terms and Conditions, as well as the general terms and conditions of iCash.One, which are available on the app. By participating in this Promotion, users agree to be bound by these Terms and Conditions.

1.2 In the event of any inconsistency between these Terms and Conditions and the iCash.One General Terms, these Terms and Conditions shall prevail with respect to matters relating to the Promotion.

1.3 iCash.One reserves the right to determine, at its sole discretion, the qualifying action(s) to which this Promotion applies, which may include, without limitation, a deposit or any other action determined by iCash.One (each, a "Qualifying Action"), as well as the merchant(s), platform(s), or website(s), if any, in connection with which such Qualifying Action may apply (each, a "Merchant", as applicable), and the applicable Benefit and the maximum reward cap, if any, referred to in Section 5 below (the "Cap").

1.4 iCash.One may make such information available to Eligible Users through any of its communication channels, and may modify, update, or discontinue it at any time, at its sole discretion and without any obligation to provide prior or subsequent notice, as set forth in Section 9.6 below.

2. Scope and Description of the Promotion

2.1 This Promotion is operated by iCash.One and offers an Eligible User (as described in Section 4 below) a benefit, which may consist of cashback or any other type of reward or benefit as determined by iCash.One (the "Benefit"), in connection with a qualifying deposit or such other Qualifying Action as iCash.One may determine and communicate, whether or not such Qualifying Action is made through, or in connection with, a Merchant.

2.2 The type of Benefit, the applicable amount, percentage, or other calculation basis, and the Cap (if any) shall be determined by iCash.One at its sole discretion and shall be as set forth in the communication sent by iCash.One to the Eligible User.

2.3 Such communication shall establish and govern the Benefit, amount, and Cap (if any) applicable to such Eligible User (or the equivalent in local currency, as determined by iCash.One's system conversion rates), together with the conditions set forth below.

3. Duration of the Promotion



3.1 This Promotion does not have a fixed term and shall remain in effect until modified, suspended, or terminated by iCash.One, at its sole discretion, in accordance with Section 9 below.

3.2 iCash.One may, at its sole discretion, indicate a specific start date, end date, or any other time-related condition applicable to the Promotion. iCash.One may modify or discontinue any such condition at any time, without any obligation to provide notice, as set forth in Section 9.6 below. In the absence of, or following any such modification of, a specific time-related condition, the Promotion shall be deemed ongoing on the terms then applied by iCash.One.

4. Eligible User

4.1 The Promotion is applicable to users that have an account in the iCash.One Digital Application.

4.2 You must be over 18 years old.

4.3 You must hold a valid iCash.One account that is active, duly verified, and not subject to suspension or restriction.

4.4 You must have received direct communication from iCash.One about this Promotion, which communication shall establish the applicable Qualifying Action, the Merchant (if applicable), the Benefit, and the Cap, if any.

4.5 You must have completed the Qualifying Action designated by iCash.One (the "Eligibility Condition"), through the iCash.One Digital Application and, where applicable, in connection with the Merchant designated by iCash.One, within the territory communicated by iCash.One. iCash.One reserves the right to determine eligibility at its sole discretion based on the Eligible User's transaction history.

5. Benefit

5.1 Eligible Users will receive the Benefit in connection with the Qualifying Action designated by iCash.One, and, where applicable, made on the Merchant designated by iCash.One, in the amount, percentage, or other calculation basis communicated by iCash.One, during the applicable period of the Promotion.

5.2 The maximum total Benefit a user can receive throughout the Promotion is subject to the Cap, if any, communicated by iCash.One (or the equivalent in local currency, as determined by iCash.One's system conversion rates).

5.3 Once a user reaches the applicable Cap, no further Benefit will be granted, even if additional deposits or other qualifying actions are made.

5.4 iCash.One reserves the right to modify the Benefit and/or the Cap at any time, at its sole discretion and without any obligation to provide prior or subsequent notice, as set forth in Section 9.6 below. Any such modification shall not affect Benefit amounts already credited prior to the modification.

5.5 iCash.One reserves the right to request Know Your Customer (KYC) documentation from any user prior to granting, crediting, or releasing any prize, reward, or Cashback under this Promotion. iCash.One may withhold, delay, or deny payment of any prize, reward, or Cashback until such documentation has been satisfactorily completed to



iCash.One's sole discretion.

6. Monthly Promotional Reward Cap

6.1 Notwithstanding any individual reward caps set forth in the applicable promotional terms and conditions, the total aggregate amount of rewards, cashbacks, and benefits credited to a user's iCash.One Digital Application Account balance through any and all active promotional campaigns shall not exceed USD 50 (fifty United States Dollars, or the applicable equivalent in local currency) per calendar month (the "Monthly Cap"). This limit applies globally across all concurrent promotions, with the exception of rewards derived from iCash.One's lottery-based campaigns.

6.2 The Monthly Cap shall reset on the first (1st) day of each calendar month.

6.3 In the event a user reaches the Monthly Cap prior to the end of the calendar month, any additional rewards or cashbacks that would otherwise be credited under any active promotion shall not be accrued or credited.

6.4 iCash.One reserves the right to modify the Monthly Cap amount at any time.

6.5 iCash.One further reserves the right, at its sole discretion, to restrict, suspend, or exclude any specific user from participating in any or all active promotional campaigns, at any time and without prior notice, based on internal eligibility criteria, risk assessment, or compliance considerations.

7. Automatic Crediting

7.1 No action or claim is required from the Eligible User in order to receive the Benefit under this Promotion. Provided the Eligible User satisfies the Eligibility Condition and any other applicable requirement under these Terms and Conditions, the Benefit shall be credited automatically by iCash.One's system to the Eligible User's Digital Application Account balance, in the amount and subject to the Cap (if any) established in the communication sent to the Eligible User pursuant to Section 4.4 above.

7.2 iCash.One reserves the right to establish, modify, or determine, at its sole discretion and at any time, the channel, format, mechanism, or timing applicable to the automatic crediting of the Benefit under this Promotion, without any obligation to provide prior or subsequent notice to Eligible Users, as set forth in Section 9.6 below.

7.3 Failure to satisfy the Eligibility Condition or any other requirement set forth in these Terms and Conditions and any instructions communicated by iCash.One shall result in forfeiture of the corresponding Benefit, without any liability whatsoever on the part of iCash.One.

7.4 iCash.One reserves the right to review, verify, approve, reject, or reverse, at its sole discretion, any Benefit credited under this Promotion, based on the Eligible User's compliance with these Terms and Conditions and iCash.One's internal risk and compliance criteria.

8. Payment



8.1 For Eligible Users who satisfy the Eligibility Condition and the other requirements set forth in these Terms and Conditions, the Benefit will be credited automatically to the iCash.One account within the timeframe communicated by iCash.One, provided that no technical or processing delays occur.

9. iCash.One's Rights

9.1 iCash.One reserves the right, at its sole discretion, to modify, suspend, or terminate the Promotion, in whole or in part, at any time, without prior notice nor responsibility whatsoever.

9.2 iCash.One reserves the right to disqualify any user from participation in the Promotion in the event of suspected or intended fraud, manipulation, or abuse.

9.3 By participating in the Promotion, users acknowledge and agree that iCash.One's determination of eligibility, the applicable Merchant and/or Qualifying Action, the Benefit and Cap, the crediting of accounts, and the interpretation of these Terms and Conditions shall be final and binding.

9.4 iCash.One reserves the right to withhold the Benefit from any user if their account is found to be in violation of these Terms and Conditions or any other applicable requirement.

9.5 iCash.One reserves the right to disqualify any user from the Promotion and recover any Benefit if fraudulent activity or abuse of the Promotion is detected or suspected.

9.6 iCash.One reserves the right to determine, modify, update, or discontinue, at any time and at its sole discretion, the Merchant and/or Qualifying Action, the Benefit, the Cap, the duration of the Promotion, the crediting mechanism, and/or any other term of this Promotion, without any obligation whatsoever to provide prior or subsequent notice to Eligible Users. Should iCash.One choose to provide any notice, update, or communication in this regard (whether via in-app notification, email, or publication on the iCash.One website), such notice is provided solely as a courtesy and shall not be construed as creating any obligation on iCash.One to provide notice of any future change.

9.7 iCash.One reserves the right to request Know Your Customer (KYC) documentation from any user prior to granting, crediting, or releasing any prize, reward, or Cashback under this Promotion. iCash.One may withhold, delay, or deny payment of any prize, reward, or Cashback until such documentation has been satisfactorily completed to iCash.One's sole discretion.

10. Limitation of Liability

10.1 To the maximum extent permitted by law, iCash.One, its affiliates, directors, officers, employees, and agents shall not be liable for any loss, damage, cost, expense, or claim of any kind, whether direct or indirect, arising out of or in connection with your participation in this Promotion, including but not limited to:

- a. delays, interruptions, or errors in the operation of the Promotion or the iCash.One Digital Application;
- b. any loss of Benefit resulting from technical failures, system errors, or



unauthorized access;

c. any act, omission, or default of third-party Merchants or partners; or



d. any reliance placed by you on information, representations, or promotional materials related to the Promotion.

10.2 This Promotion is provided without any warranty, representation, or condition of any kind, whether express or implied, including but not limited to implied warranties of merchantability, fitness for a particular purpose, or non-infringement.

10.3 iCash.One shall not be responsible or liable for any failure to credit, delay, or error in awarding the Benefit due to technical, operational, or communication failures, or any other circumstances beyond iCash.One's reasonable control.

10.4 The Benefit amount reflected in the user's account shall be deemed final and conclusive, and iCash.One shall not be obliged to provide any further explanation, review, or recalculation.

10.5 iCash.One reserves the right to revoke or adjust any Benefit credited in error, including where system or technical faults have resulted in an incorrect amount being displayed or credited.

10.6 Google LLC and Apple Inc. are not sponsors of, and are not involved in any way with, this Promotion. All rules, conditions, and rewards are the sole responsibility of iCash.One.

11. Force Majeure

iCash.One shall not have any liability under, or be deemed to be in breach of, these Terms and Conditions for any delays or failures in performance of any of its obligations under these Terms and Conditions that result from a Force Majeure Event.
